## BLS or Heartsaver CPR Instructor Monitoring Fees 2019

(Fee includes alignment with our AHA Training Center [Allied 100]. Does not include alignment fees if aligning with another Training Center. Contact that Training Center for information on their alignment fees.)

### Post In-class Instructor Course (Initial certification or renewal)

#### Option 1 - \$100.00 (\$30.00 per each BLS certificate and BLS student manual)

We monitor **YOUR students at OUR location using OUR equipment**. Price includes monitoring fee, room use, and equipment rental. Student books, and student course completion cards (certificates) are an additional fee. If any student does not want a BLS certificate, they do not need to have a BLS student manual, and you do not need to pay the additional fee for that student. You may have up to 4 students. Please note that we only allow this for instructor monitoring. We typically do not rent out our classroom.

#### Option 2 – \$150.00 (Does not include student materials or student BLS cards)

We monitor you teaching **YOUR students at YOUR location YOUR equipment**. We will travel up to 40 miles from La Mesa. **You are responsible for obtaining the students' manuals and all other required training equipment and materials** (except the written exams, which we will bring). You may have 2-4 students, with a preferred student-to-manikin ratio of 1 student per 1 manikin. Our equipment is available for rent. Please use the [supply rental form](#) if you need to rent equipment. If any student does not want a BLS certificate, they do not need to have a BLS student manual, and you do not need to pay the additional fee for that student.

### Instructor Renewal (Instructor card not expired and declining the classroom course)

#### Option 1 - \$300.00 (Includes your new Instructor card. Does not include student manual or student BLS cards)

We monitor **YOUR students at OUR location using OUR equipment**. Price includes monitoring fee, room use, and equipment rental. You are responsible for providing student manuals and for processing your student's course records and course completion cards (certificates). If any student does not want a BLS certificate, they do not need to have a BLS student manual. You may have up to 2 students. Please note that we only allow this for instructor monitoring. We typically do not rent out our classroom.

#### Option 2 - \$350.00 (Includes your new Instructor card. Does not include student manual or student BLS cards)

We monitor you teaching **YOUR students at YOUR location YOUR equipment**. You are responsible for obtaining students' books and all other required training **equipment and materials**. You are responsible for processing your student's course records and their course completion cards (certificates). If any student does not want a BLS certificate, they do not need to have a BLS student manual. You may have up to 4 students, with a maximum student-to-manikin ratio of 2 students per 1 manikin. Our equipment is available for rent. Please use the [supply rental form](#) if you need to rent equipment.

**BE PREPARED!!** If at any time your course does not follow the AHA standards & guidelines, the TCF monitoring you will stop your class and you will need to reschedule your monitoring for another date. ## **Cancellation and Rescheduling Policies (BLS Monitoring)**

- **If you do not show up** for your monitoring date, you will forfeit your fees and you must re-pay the **full monitoring fee** to reschedule.
- Please arrive early! **If you are late** you will not be monitored and you will be charged the **full monitoring fee** to reschedule.
- **Rescheduling** of your monitoring session must be received **3 BUSINESS DAYS** in advance (Mon-Fri, 9:00am to 4:00pm) prior to your scheduled monitoring date or you will be charged a **\$50.00 rescheduling fee**.
- Your monitoring session may be rescheduled a maximum of 2 times and only with 3 business days' notice (Mon-Fri, 9:00am to 4:00pm), after which, you will be charged the **full monitoring fee**.
- Receipt and confirmation expire in **90 days** after which fees will be forfeited.
